

TA INVESTMENT DECLARES UNIT SPLIT FOR TWO ("2") FUNDS FOR AUGUST 2024

TA Investment Management has declared a unit split exercise for the registered unit holders of TA Comet Fund and TA Dana Fokus as at 29 August 2024.

The unit split exercise was conducted because the two Funds have demonstrated consistent and steady appreciation over a six-month period.
